



How does rate mitigation work?

In 2008 the law governing the rating of empty commercial properties was altered dramatically. With a few exceptions, any owner of a long term vacant property is liable to pay rates in full. Owners of vacant properties are entitled to an initial rates holiday of 3 months (offices/retail) or 6 months (industrial/warehouse) when the property first reverts to them following a period of at least 6 weeks of continuous occupation*.

We can help you to take advantage of this provision by implementing a managed short term occupation strategy. A vetted occupier takes occupation of your property for 6 weeks, triggering a fresh rates holiday. This process can be repeated upon the expiry of the rates holiday, thus eliminating the majority of your rates liability on an ongoing basis.

Contracts signed and owner pays circa 7 weeks rates to cover tenant's cost. Occupiers will sign a tenancy agreement (incorporating rolling landlords' break clause).

Billing authority informed of new occupier and 7 weeks of occupation begins with tenant making rates payments for period of occupation. 3 or 6 month rate holiday begins.
This process can be repeated if necessary. LIG Group fees payable upon confirmation relief has been awarded.



Occupier takes physical occupation (e.g. by moving merchandise in).

After 7 weeks, the tenancy will expire and the occupier vacates the property. The billing authority will then be informed of vacancy.



How does Guardianship work?

Once authorised, our in-house team of maintenance operatives initiate the building works required for a safe, compliant & liveable environment for Guardians.

Our team will then install our patented high-security master lock system with anti-pick and anti-theft technology.

The full onboarding process, including property takeover, fit out, and securing the site with our vetted Guardians takes approx. 5-10 days.

The Guardians will secure your site through occupation and will keep us informed of any maintenance issues which our in-house team will promptly sort.

When you need your property back, simply serve 28 days notice and we'll return your property with vacant possession, often in a better state that we received it in.

Who are the Live-in Guardians?

Our Guardian community is made up of key workers and young professionals who have typically struggled to find affordable housing. All our Guardians must meet a rigorous set of criteria and are required to provide bank statements, references, passport verifications and proof of ID as well as passing a DBS check.

All Guardians are interviewed to ensure they are aware of their responsibilities, and are given access to our dedicated Guardian welfare department for help with any issues, so that property owners can feel confident that their asset is being well looked after by responsible people.






